Reported Oil Spill Under Investigation




Oceanside, Calif. - California Department of Fish and Wildlife's Office of Spill Prevention and Response (OSPR) is investigating an oil spill that occurred off the coast of San Diego County this morning shortly before 6 a.m.

Initial reports to the Office of Emergency Services indicate a discharge of crude oil from a ship collision that took place 34.5 miles of the coast of Oceanside. Reports also indicate the collision was between an oil tanker and another vessel. Chevron Shipping Company, which was operating the tanker, has inliked a response to the incident.

OSPR personnel enroute include wildlife officers, environmental <u>scientists</u> and oil spill prevention specialists. The team will evaluate the scope of the spill once on-scene.

The amount of oil discharged is unknown at this time and under investigation. More information will be released as it becomes available and is confirmed by the response team.
