Resulting Pollution Laws

• SB 2040 or Lempert-Keene-Seastrand Oil Spill Prevention and Response Act passed 9/90.

• Federal Oil Pollution Act (OPA–90) passed 10/90.

The Lempert-Keene-Seastrand Oil Spill Prevention and Response Act

- Created the Office of Spill Prevention and Response (OSPR) within the Department of Fish and Game on January 1, 1991
- Created the position of Administrator.
- The Administrator is appointed by the Governor and approved by the Senate.

Duties of the Administrator

• Primary authority to direct oil spill cleanup in marine waters.

• State authority over use of all response methods.


Funding

- Oil Spill Prevention and Administration Fund
- Oil Spill Response Trust Fund

\$.065/bbl of petroleum coming into California

OSPR's Jurisdiction

• 42 gallons of oil in Marine Waters

• Oil: Must be petroleum based

• Marine Waters: Subject to tidal influence

OSPR's Mission

To provide the **best achievable protection** of California's natural resources by preventing, preparing for, and responding to spills of oil and other deleterious materials and through restoring and enhancing affected resources.

Restoration

Overall Goal of Natural Resource Damage Assessment (NRDA)



- Return injured natural resources to pre-spill condition
- Compensate for interim losses through the restoration, rehabilitation, replacement or acquisition
