2. The estate or interest in the land described or referred to in this schedule covered by this policy is a fee.

3. The land referred to in this policy is situated in the
County of Sonoma, State of California, and is described as follows:

Being the 10 acre parcel of land in the Southeast 1/4 of Section 23, T. 7 N., R. 10 W. M.D.B. L.M. previously in Book 1860 of Official Records, page 539, Sonoma County Records and corrected to true bearing from North established by L.S.C. 2297 in 1946.

Beginning at a 1 1/2" iron pipe monument in stone, marking the Southeast corner of the Northwest 1/4 of Section 23, set by the first later County Surveyor of Sonoma County in 1902 accepted as the true Southeast 1/16 corner of said parcel; thence, from said 1 1/2" iron pipe monument, along the East line of the parcel of land described in Book 510 of Official Records, page 539, Sonoma County Records, North 89° 43' West 444.35 feet; at 187.5 feet a 1 1/2" line pipe, set; at 444.35 & N 1/2 E 3.72 feet a 1 1/2" iron pipe, tagged RE2227 bears North 75° 45' East 3.72 feet; thence, along the East line of the parcel of land described in Book 510 of Official Records, page 539, Sonoma County Records, North 0° 10' 40" East 316.9 feet a 1 1/2" line pipe; at 666.2 feet a 1 1/2" line pipe; at 980.30 feet a 1 1/2" iron pipe monument marking the Northwest corner of said 10 acre parcel, being the Northeast corner of the above described 10 acre parcel, from which a 1 1/2" iron pipe, tagged RE2227, bears North 24° 18' West 39.65 feet; thence South 89° 43' East 444.35 feet to a 1 1/2" iron pipe monument, from which a 1 1/2" iron pipe, tagged RE2227 bears North 34° 53' West 65.34 feet; thence South 0° 05' 40" West at 293.3 feet a 1 1/2" line pipe; at 805.3 feet a 1 1/2" line pipe; at 980.3 feet the point of beginning, and having an area of 10 acres. All 1 1/2" iron pipe monuments set are tagged L.S.C. 2297. The closure of the survey in bearing and distance meets the requirements of Third Order, U.S.C. & Geodetic Survey.

Including a Right of Way 20 feet wide along the southerly line of the Ballard Tract, the southerly line of which is North 89° 43' West 444.35 feet from the Southwest corner of the above described parcel; thence, over a 40-foot road easement, extending from the Western end of the said 20 foot right of way the easterly line of which is South 42° 09' West 135 feet to a point in the center of Stoetz Lane.
